unrise of Pasco founded in 1982 by a of survivor domestic violence with the goal of providing services fellow to survivors in need. Throughout the Sunrise past 40 vears. remained committed to helping individuals and families affected by domestic and sexual violence.

Domestic violence is a pattern of behavior used by one partner to gain power and control another within intimate an relationship. This can include physical violence, sexual violence, emotional abuse. economic abuse. and stalking. Sexual violence is any kind of sexual activity or contact that is unwanted and/or forced by one person upon another.

Sunrise provides a wide range of wrap around services, including a 24-hour hotline, safety planning, crisis intervention, legal advocacy, counseling, emergency shelter, support groups, and more. These services are provided at no cost to help survivors of domestic and

sexual violence reclaim their lives.

Additionally, prevention education is provided by Sunrise. This consists of workshops focused on topics like bystander intervention, healthy relationships, and more.

In this annual impact report, you'll find an overview of our efforts and successes. We invite you to join us as we strive to end domestic and sexual violence in our community.

Through our organization values, we commit to:


- Provide survivor focused, trauma-informed services through an empowerment-based approach.

- Enhance service provision through a dedication to employee professional development and training.










24-HOUR CRISIS HOTLINE









OUTREACH: COUNSELING, ADVOCACY, SUPPORT






VIOLENCE PREVENTION

The Prevention Team focuses on specialized training for professional groups in the community. The team consistently works with law enforcement health care providers. Together with the Pasco community, Sunrise is working to stop violence before it starts. The current team consists of 2 full-time staff which are dedicated to the implementation of the violence prevention strategies on the Saint Leo University campus.








INJUNCTION FOR PROTECTION (IFP) PROJECT

- <u>Solutions Thrift Store</u>: Duties include displaying merchandise, running the cash register, sorting donations.
- <u>Direct Service</u> (Internship and Volunteer Opportunities): Help with group sessions, advocacy, safety planning, answering the 24-hour crisis hotline and so much more.
- Special Events: Currently, Sunrise holds four major fundraisers throughout the year. This includes two breakfast events, a golf tournament, and a clay shoot. Volunteers serve on planning committees and help out the day of these events to help ensure success.
- <u>Day of Caring</u>: Two ways to give back: 1) Plan a special day for your group to assist with pressure washing, tree trimming, maintenance tasks, help organize closets or storage areas, etc.; 2) Organize a food drive, supply drive, or help organize closets or storage areas.
- <u>Administrative Office</u>: Duties may include filing, making files, copying, shredding sensitive documents and helping with grant activities.
